Privacy Statement

Camano Island Fire and Rescue operates websites on the Internet in order to provide services to the residents of Camano Island. In providing these services, information about visitors to a website may be collected automatically or may be submitted by the website user. Camano Island Fire and Rescue recognizes the public's concern about privacy on the Internet. This privacy statement establishes how information gathered about you from your visit to our website will be used by this website's operators. As a visitor, however, you should be aware that much information submitted to Camano Island Fire and Rescue is public information under the laws of the State of Washington. Under some circumstances, we may be required to disclose such information in accordance with the Washington Public Records Act or other legal requirements.

I. Notice / Awareness

Information Collected Automatically about the Computer Which Browses or Downloads Information from this Website

We may collect and store information for statistical purposes. For example, we may count the number of visitors to the different sections of our site to help us make them more useful. The information collected may include such items as the name and domain of the host from which you access the Internet, the Internet Protocol (IP) address of the computer you are using or your browser software and operating system. This information does not identify you personally.

Personally Identifying Information Collected from E-mails or Web Forms

By sending us an e-mail (electronic mail message) or filling out a web form, you are sending us personal information (i.e., your name, address, e-mail address or other information). We store this information in order to respond to or process your request or otherwise resolve the subject matter of your submission.

Information Subject to Disclosure under the Washington Public Records Act or Other Legal Requirements

Certain information that you provide to us is subject to disclosure under the Washington Public Records Act (RCW 42.56) or other legal requirements. This means that if it is specifically requested by a member of the public, we are required to provide the information to the person requesting it.

Website Links to Other Sites Not Covered by Our Privacy Policy

Our website also contains links to information located on websites maintained by other public agencies and private organizations. This privacy statement describes the information gathering practices and procedures of Camano Island Fire and Rescue. Once you access an individual document that links you to another website, you are subject to the privacy policy of the website containing that document.
