

Fire Chief's Report

- EMS Levy Election Results
 - o 86.05% approval!
 - o 5,706 votes (10,853 voters), 53% turnout
 - Much higher positive support than we were expecting. Many thanks to staff, firefighters, and our citizens group in getting the word out about how important this was for us.
- Community Events

- Citizen Advisory Group
 - We are accepting applications from individuals interested in being a part of our citizen advisory group. Chief Yengoyan is collecting a list for review.
- Point and Pay
 - Linda is working with Island County to determine if we can join in on their contract to provide this service to our citizens. Would allow citizens to use credit cards for class payments, ambulance transport bills, meeting room use, etc.
- Shift/staff meetings
 - o Chief Schick is holding monthly informal meetings with administrative personnel, each shift as well as volunteers. Primary purpose of the meetings is to make sure all personnel have up to date information on changes and to serve as a vehicle to pose questions directly to the Chief.
- Rope Rescue Policy/Procedures
 - We have instituted a new procedure for rope rescue calls
- Meeting with Chief Cermak
 - Chief Schick met with Chief Cermak from NCRFA. We are still keeping the door open to collaborative efforts between our departments.
- Response Times
 - A review of the monthly response time averages was given to the board. We have seen a dramatic decrease in response times within the Stn 1-5 district. This could be due in part to have a day time paramedic at Stn 1-5 as well as recognition by the volunteers that we are focusing on response times throughout the district.
