ICOM – Commissioner Lich gave a report. There will be a 5% increase in user fees.

Communications/Legislative – Commissioner Treml & Chief Schick gave a report on the conference call held with Public Affairs Liz Loomis on November 11, 2016, where the fire levy was discussed.

Commissioner Shouse would like to see a cost break-down of what, and how much, the lid lift would cover. Commissioners Shouse and Treml will participate as private citizens on the Citizens for Camano Island Committee and Commissioner Metz will be the alternate.

<u>WFCA Conference</u> – Commissioners Treml and Williams gave a report. Notes from the conference were handed out, with more to follow. Legislative Day is January 26, 2017.

2017 Budget - Final Reading, Resolution & Budget Adoption and Levy Planning -

Commissioner Treml moved to approve the 2017 Budget Resolution 2016-14, Levy Certification, Resolution 2016-15 Fire Levy, Resolution 2016-16 EMS Levy, and Resolution 2016-17 Substantial Need as presented. Commissioner Metz seconded; motion carried by unanimous vote.

SCBA Interlocal Agreement Language -

Commissioner Treml moved to allow Chief Schick to sign the MOU and Interlocal Agreement with North County Regional Fire Authority to participate in the AFG Grant for SCBA Equipment. Commissioner Shouse seconded; motion carried by unanimous vote.

Request from SNOCO FF's Pipes & Drums – Request for a possible donation or "near" donation of one of the District's surplused ambulances. Discussion held. A motion was made to grant the near donation. It was the consensus of the Board to table the vote until the next meeting. Chief Schick to contact SNOCO Pipes & Drums to see what they consider a "near" donation to be. Chairman Williams suggested that one of the surplused ambulances be used by the District for a Pub Ed vehicle.

Meeting Times and Locations – Discussion was held regarding changing the Board meetings to an earlier time, and also eliminating holding the meetings at the various fire stations throughout the year since there has been hardly any public attendance. It was the consensus of the Board to hold some of the 2017 meetings at 4:00 pm instead of 7:00 pm, at least for the first part of 2017, based on Commissioner schedules. Actual schedule to be worked out later. It was also the consensus of the Board to keep the rotating meeting location schedule for 2017 and then will re-address the question for 2018.

<u>Chief Pay Increase</u> – It was the consensus of the Board to align Staff pay increases with the Local 4033's Collective Bargaining Unit contract pay increases.
