NEW BUSINESS

<u>Snohomish County PUD Easement</u> – A/C Helgeland reported the District has been contacted by PUD. They are requesting an easement to move a power pole on Chapman Road, behind the Camano City Fire Station. If the pole is moved to the other side of the street, it's possible the power lines may encroach on the District's property The District's attorney has reviewed the proposed contract language with some edits. A/C Helgeland reports Island County is now reviewing the information to verify whose property the pole will actually sit on. Information will follow in the coming weeks.

<u>Chelan Seminar Report</u> – Commissioners Lich, Treml and Shouse gave a brief report on the information presented at the seminar. There was a discussion on the importance of strategic and succession planning.

<u>Review Commissioner and Chief's Goals</u> – Chief Schick reviewed his goals and Commissioner Williams reviewed the goals for the Board.

<u>LOU – Additional Part Time Fire Fighter Position</u> – Chief Schick presented a draft copy of the LOU to the Board. There was a discussion regarding the need for additional staffing as a trial for the remainder of the year. The Union President stated he would present it to the Local at their next meeting.
