<u>Strategic Plan</u> – On hold until the new Fire Chief is hired.

Draft of Current Fire Chief Contract Discussion -

Commissioner Treml moved to approve the amended contract for Fire Chief Michael Schick. Commissioner Evans seconded: motion carried by unanimous vote.

NEW BUSINESS –

Resolution 2019-02 - Meeting Location Change -

<u>Commissioner Lich moved to approve Resolution 2019-02 – Meeting Location Change.</u> <u>Commissioner Krieg seconded: motion carried by unanimous vote.</u>

<u>Warm Beach Proposed Usage of CIFR logo for Promotional Item</u> – Discussion held. Commissioner Treml stated that the District should develop set criteria for possible future requests for logo usage. It was the consensus of the Board to allow Warm Beach to use CIFR's logo for their Care Continuity Program that is being assisted by the District's Community Paramedic Jim Reinhardt.

<u>New Fire Chief Contract Discussion</u> – Discussion held. Board reviewed the proposed contract for the new Fire Chief and compared it to others in the region. Two adjustments were made:

- 1. Vacation Bank Max and Vacation Cash Out max changed to 400 hrs.
- 2. Severance Package changed to six months.

<u>Commissioner Treml moved to approve the new Fire Chief's contract. Commissioner Evans</u> <u>seconded: motion carried by unanimous vote.</u> Discussion held regarding contents of contract.

Commissioner Treml moved to approve the new Fire Chief's contract with the specified changes to the Vacation and Severance Package. Commissioner Lich seconded: motion carried by unanimous vote.

<u>Commissioner Treml moved to offer the position of Camano Island Fire & Rescue Fire Chief to Levon Yengoyan. Commissioner Krieg seconded: motion carried by unanimous vote.</u>

Increased Station Staffing Template – Discussion held. The Board would like to see some data regarding this and the financial impact brought to the March 11th meeting, including NFPA Standards.

<u>Draft SOP for Volunteer Staffing Requirements</u> -

- Lt. Norman will coordinate with Board Secretary Tiner to schedule a meeting between the Board and Volunteer members to discuss the Volunteer Program.
- Commissioner Evans would like to see call volume statistics from surrounding agencies with similar demographics for review for Volunteer Program and proposed Staffing template.

PUBLIC INPUT – Citizen Cynthia Smith:

- asked if there would be an "after action report" regarding the recent snow storm. The Board stated that some of the measurements requested cannot be tracked.
- Made a comment on the consistency of response times between all the District fire stations, but does not feel our data properly reflects the calls for Sta. 1-5.
