UNFINISHED BUSINESS –

<u>COVID Sick Time Reimbursement</u> – Chief Yengoyan requesting Board approval for coverage of sick time hours employees use due to COVID. Would put the sick time back into their sick banks. Discussion held. Board members expressed some concerns:

- This situation could extend for a long time.
- Setting a precedent what if there is a second wave, or what if a situation like this happens again.

- Feels that is what their sick pay is for.
- Concern that people may not stay home when sick because they want the sick pay cash out.
- Want some kind of mechanism in place to ensure this is a one-time thing. Possibly sign some type of paperwork. This needs to be tied to the Emergency Declaration at this time.
- Possibly renegotiate sick time in the next Contract.

Chief stated that, once the Emergency Declaration is over, or potentially sooner, business will go back to normal and normal sick leave policy. Any Overtime created due to sick leave due to COVID will be covered by the Grant. And A/C Allen will approve any sick time due to COVID.

Commissioner Treml moved to reimburse sick leave for COVID-19 for the duration of the Public Health Emergency or until the District is back to normal operations, whichever occurs sooner. Commissioner Krieg seconded; motion carried by unanimous vote.

<u>NEW BUSINESS</u> –

Budget Amendment 2020-01 -

Dr. Krystal Baciak's Contract -


